

**VILLAGE OF PEMBERVILLE
COUNCIL MEETING
February 19, 2013**

Mayor Bowman opened the February 19, 2013 meeting at 7:00pm with a prayer and led those present in the Pledge of Allegiance.

Roll Call: Present at the regular meeting of council was Campbell, Bockbrader, Cox, Long, Rothenbuhler, and Schuerman. Others present were Ed Wozniak, Duane Martin – Pemberville-Freedom Township Fire Chief, Tom Dunn – Buckeye Sanitation, Chief Darling, and the clerk.

Minutes: Cox moved and Campbell seconded to approve the February 5, 2013 regular meeting minutes. Motion passed unanimously.

Treasurer's Report: Rothenbuhler made a motion to approve payment of bills in the amount of \$4,401.24 and Schuerman seconded. The motion passed unanimously.

Buckeye Sanitation:

Tom Dunn, Buckeye Sanitation, explained that there will be changes within the garbage collection process to provide solutions to current problems. First residents are becoming tardier in purchasing their quarterly stickers. Therefore no trash will be collected for any customer who has not purchased their sticker by the 15th of the first month of each quarter until the sticker has been purchased. Second there have been fraudulent bag stickers and therefore Buckeye Sanitation is switching their style of tags. Third, they are installing new software which will open additional payment options.

Mayor:

March calendar was distributed. The Tree Commission will be meeting on March 12 at 3pm. This will be added to the calendar.

Financial reports were distributed.

Police Report was distributed.
