**ORDINANCE AUTHORIZING THE PURCHASE OF A
NEW COMPUTER SYSTEM, INCLUDING HARDWARE AND SOFTWARE ITEMS, AND
DECLARING AN EMERGENCY.**

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF PEMBERVILLE,
COUNTY OF WOOD, AND STATE OF OHIO:

SECTION 1: That the Fiscal Officer is authorized to purchase on behalf of the Village a new computer system, including certain hardware and software items, in accordance with the exhibit attached hereto and made a part hereof.

SECTION 2: This ordinance shall take effect as an emergency measure. The reason for the emergency is that the prompt effectiveness of this measure is necessary in order to have appropriate systems in place for the Village Income Tax season, and in order to maintain existing and appropriate utility records and billing records, as the current system has begun to fail, and immediate action is necessary in order to protect the public health, safety and well being of our citizens.
